# MEMBERSHIP APPLICATION AND AGREEMENT

I am a member of the Apes Hill Club Homeowners Association Inc. (the "HOA") or a duly authorized officer acting on behalf of a corporate member of the HOA and have come to understand that:

- (1) the HOA is controlled by Apes Hill (Barbados) Inc. (formerly known as "Plantation Sanctuary Inc." ("PSI") through an HOA Board of Directors appointed by PSI.
- (2) approximately 120 other members of the HOA who are not PSI have absolutely no voice in the operation, management, and control of the expenses of the HOA.
- (3) the HOA (a) refuses to hold annual membership meetings at which the business of the HOA can be conducted, including the election of a Board of Directors that is not appointed by PSI; (b) is attempting to mandate that all HOA members also become members of an entity to be formed and controlled by PSI, called the Apes Hill Club (the "Club"), to operate a golf club at the Apes Hill Development, and (c) requires all members of the HOA to pay an initiation fee of US\$125,000 to the Club, to pay US\$20,000 per annum in dues to the Club, and to cover the operating losses of the Club after its first year of operation as a golf club and (d) allows the Board of Directors of the HOA to operate the HOA under Rules that provide that HOA Directors appointed by PSI owe a fiduciary duty to PSI alone, and not to the HOA and all its members as required by the Companies Act of Barbados.
- (4) the Apes Hill Benevolent Society Inc. (the "Society") was formed to uphold the rights of current and future HOA members through among other things, representative civil action by the Society, against the HOA, its current Board of Directors, and/or PSI, for the acts and omissions set out above, which are oppressive, unfairly prejudicial to, and unfairly disregard the interests of the HOA members, contrary to law.

I further understand that a group of HOA members (the "Owners Group") have caused the activities of the HOA and its current Board of Directors to be investigated by counsel; have caused the Society to be incorporated on December 7, 2021, as non-profit company under the laws of Barbados; and have received opinions from counsel to the effect that:

- (A)The HOA must hold Annual Membership Meetings at which the business of the HOA can be conducted, including the election of a HOA directors by the HOA members.
- (B) PSI has no authority to appoint any Directors of the HOA.
- (C) Any Director of the HOA who is appointed by PSI, acts with fiduciary duties to the HOA and all members of the HOA, not just to PSI, notwithstanding any provision to the contrary in the 2021 Rules of the HOA.
- (D) Under the constating documents which govern the HOA, no power to appoint HOA Directors is given to the Developer/PSI. In an attempt to get around this, the Directors unlawfully appointed by PSI have enacted the subsidiary 2021 Rules of the HOA, which purports to confer such power on PSI, as well as to confine the fiduciary duty of the HOA Directors to PSI alone rather than to all the HOA members as required by the Companies Act of Barbados, and to impose (without any authority to do so in the constating documents) mandatory golf club membership (with exorbitant mandatory fees) on all members of the HOA. This is entirely unlawful.

I also understand that the Society was established to represent the interests of all members of the HOA who oppose the actions taken by PSI and the PSI controlled Board of Directors of the HOA, and that members of the Owners Group are willing to execute Deeds of Assignment of Claims to the Society to allow the Society to prosecute their claims against the HOA, its current Board of Directors and /or PSI on behalf of all members of the Society, provided the Society raises at least US\$50,000 or BD\$100,000 in Membership Fees by October 15<sup>th</sup> 2022, to be applied by the Society to cover the legal expenses of the Society in prosecuting assigned claims against the HOA, its current Board of Directors and/or PSI.

NOW THEREFORE, I hereby apply for Membership in the Society, by signing this Membership Application and Agreement (hereinafter collectively referred to as the "AGREEMENT") and I:

The AGREEMENT constitutes the entire agreement and understanding between the parties with respect to the subject matter hereof. No amendment of any provision of the AGREEMENT shall be effective unless it is in writing and signed by the parties and no waiver of any provision of the AGREEMENT, nor consent to any departure by either party from it, shall be effective unless it is in writing and signed by the affected party, and then such waiver or consent shall be effective only in the specific instance and for the specific purpose for which it was given.

- 2) Pay the Society's Annual Membership Fee of US \$2,500 or BDS \$5,000 by:
  - a. bank transfer to RBC –US\$ Account No. 094358004699 or to RBC –BD\$ Account No. 094351099977 as per the attached wire instructions; or
  - b. by cheque written to the order of "Apes Hill Benevolent Society Inc." in US\$ or BBD\$ and deliver it by mail to the Society at the address shown above.

Membership in the Society commences on acceptance of the AGREEMENT by the Board of the Society and payment of your annual membership fee to the Society and ends by its own terms on November 15, 2023, unless further extended by the Society.
